India imported \$6.21 billion worth of solar photovoltaic cells and modules from China during the financial year 2023-24. A year ago, the imports stood at \$2.25 billion. A year ago, the imports ...

In the solar industry, the U.S. imposed AD/CV duties on Chinese solar cells and panels in 2012 (U.S. ITA 2012). In 2014, tariffs were expanded to solar panels assembled using Chinese or Taiwanese cells regardless of country of origin (U.S. ITA 2014, 2015).

Further, the scope of materials which can be imported is being expanded. On the other hand, solar glass for manufacture of solar cells or solar modules will attract 10% customs duty from Oct. 1 this year. Tinned copper interconnect for manufacture of solar cells or solar modules will also attract 5% customs duty from Oct. 1.
