Will China's anti-subsidy investigation lead to increased tariffs on electric vehicles?

On 4 October 2023, the European Commission initiated an anti-subsidy investigation that could lead to increased tariffson imports of Chinese electric vehicles to the European Union and has broader implications for the global electric vehicles market.

Are new battery electric vehicles under investigation?

I. New battery electric vehicles under investigation protect the European electric car industry The products subject to this investigation are new battery electric vehicles, designed primarily to carry nine or fewer persons, including the driver, and propelled solely by one or more electric motors, regardless the number of wheels set in motion.

Is the European Commission launching an anti-subsidy investigation into electric vehicles coming from China?

On 13 September 2023,Ursula von der Leyen,the president of the European Commission,announced that "the Commission is launching an anti-subsidy investigation into electric vehicles coming from China," which was followed by the publication of a notice on 4 October 2023 to initiate the anti-subsidy investigation.

Will Xinhua impose punitive tariffs on Chinese electric vehicles?

Xinhua Chinese electric vehicles have come under spotlight recently following the European Commission's announcement that it was initiating an anti-subsidy investigation into them. The probe's outcome will determine whether to impose punitive tariffs against them.

How long after initiation can a subsidy investigation be concluded?

The investigation will be concluded within maximum 13 months of initiation. If legally warranted, any provisional anti-subsidy duties may be imposed by 9 months after initiation, with any definitive measures to be imposed up to 4 months later or within 13 months of the initiation of the investigation.

What if Chinese subsidies affecting EV imports are countervailable?

If the Commission determines that Chinese subsidies affecting EV imports are countervailable and have caused material injury to EU industry, it may impose countervailing duties (i.e., import tariffs) on imports of Chinese EVs for five years (which can be extended for successive five-year periods following an expiry review).
