

# Two exclamation marks for new energy batteries

What does a battery with an exclamation mark mean?

A battery with an exclamation mark means a warning message that your gadget needs attention and can't hold a charge for longer. If you ignore it, your device will eventually stop working and won't turn on anymore. To remove this symbol, keep reading. What does the battery with the exclamation mark mean?

Does a battery need a CE marking?

The manufacturer shall affix the CE marking to each individual battery that meets the applicable requirements or, where that is not possible or not warranted due to the nature of the battery, to the packaging and the documents accompanying the battery.

What does the exclamation mark mean on a phone?

On mobile devices, the exclamation mark means that the battery is not working properly and must be replaced immediately. In some cases, the battery isn't communicating properly with your phone's logic board due to a faulty battery. Thus, getting a new battery is recommended before you experience severe problems.

What does the Kindle battery exclamation mark mean?

The Kindle battery exclamation mark means that the battery is not functioning correctly. You should reset your Kindle tablet and see if you can get rid of the error message. If the problem continues, there might be something wrong with your tablet's internal component, which needs to be repaired by a professional.

The CE conformity assessment and CE marking requirements started to apply on 18 August 2024. Initially, requirements for carbon footprint, recycled content and performance and durability requirements for portable batteries of general use will not be part of the CE-marking but will be added at a later date.
